Investment objective

The investment objective of the Parallel Conservative Growth Portfolio is to achieve capital growth over the medium term (5 years plus). The Portfolio offers exposure to a range of collective investments providing diversity across regions and asset classes. To reduce investment risk the Portfolio maintains a bias towards fixed income and cash, with equity holdings limited to 35%.

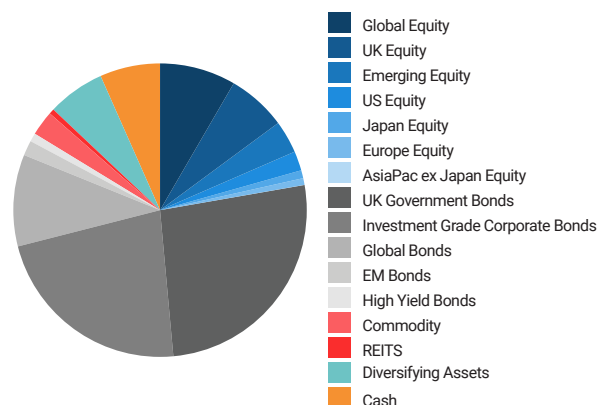

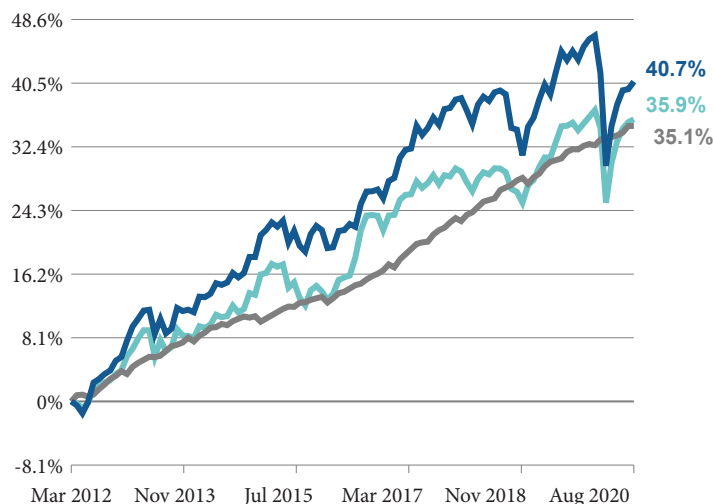

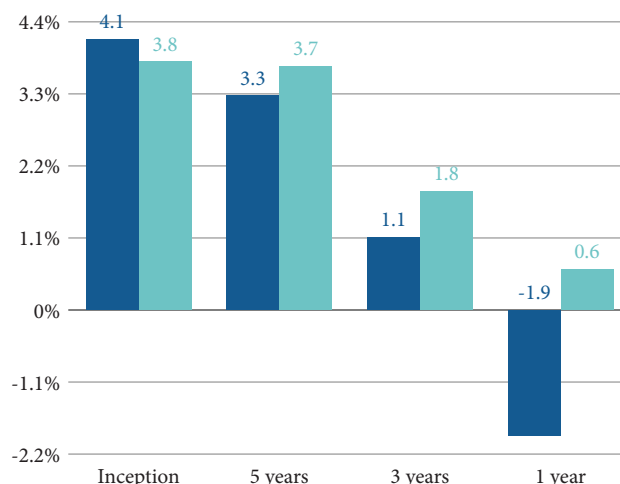
Parallel Conservative Growth - B Portfolio GBP from 30 Mar 2012 to 31 Aug 2020
