Multi Asset A - Defensive Growth

The investment objective of the Parallel Defensive Growth Portfolio is to achieve capital growth over the medium term (5 years plus). To reduce investment risk the Portfolio maintains a bias towards fixed income and cash, with equity holdings limited to 20%.

Benchmark: Composite 35% IA Money Market & 65% IA Mixed Investment 0-35% Shares.

The Portfolio has a targeted return of the Consumer Price Index (CPI) + 1% over a rolling three-year period.

Multi Asset B - Conservative Growth

The investment objective of the Parallel Conservative Growth Portfolio is to achieve capital growth over the medium term (5 years plus). To reduce investment risk the Portfolio maintains a bias towards fixed income and cash, with equity holdings limited to 35%.

Benchmark: IA Mixed Investment 0-35% Shares

The Portfolio has a targeted return of the Consumer Price Index (CPI) + 2% over a rolling three-year period.

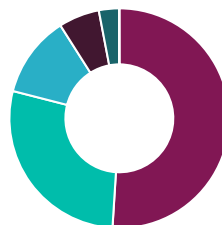
Multi Asset C - Cautious Growth

The investment objective of the Parallel Cautious Growth Portfolio is to achieve capital growth over the medium term (5 years plus). To provide the potential for greater returns than those available from fixed income and cash the Portfolio may have a bias towards equity holdings, although this will be limited to 60%.

Benchmark: IA Mixed Investment 20-60% Shares

The Portfolio has a targeted return of the Consumer Price Index (CPI) + 3% over a rolling three-year period.

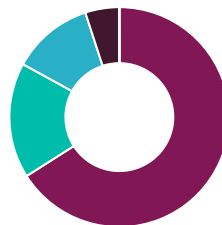
Multi Asset D - Balanced Growth

The investment objective of the Parallel Balanced Growth Portfolio is to achieve capital growth over the medium term (5 years plus). To provide the potential for greater returns than those available from fixed income and cash the Portfolio may have a bias towards equity holdings, although this will be limited to 85%.

Benchmark: IA Mixed Investment 40-85% Shares

The Portfolio has a targeted return of the Consumer Price Index (CPI) + 4% over a rolling three-year period.

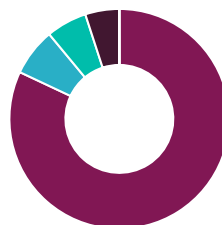
Multi Asset E - Adventurous Growth

Benchmark: IA Flexible Investment sector

The Portfolio has a targeted return of the Consumer Price Index (CPI) + 5% over a rolling three-year period.

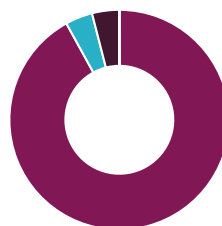
Multi Asset F - Global Opportunities

Benchmark: IA Flexible Investment sector

The Portfolio has a targeted return of the Consumer Price Index (CPI) + 6% over a rolling three-year period.
